Teamwork: E-news from the Enhancing Interdisciplinary Collaboration in Primary Health Care (EICP) Initiative

Letter from the Steering Committee

The pace has not slowed for the EICP Initiative, and we have much to report.

First, we are about to publish **research** about the workable options associated with interdisciplinary collaboration among primary health care professions on the front line of health care—care providers such as physicians, nurses, dietitians, occupational therapists, pharmacists, psychologists, physiotherapists, social workers, speech-language pathologists and audiologists. As our research reports are completed they will be posted on the EICP web site (www.eicp-acis.ca).

We've also posted reports based on our first wave of small group consultations with the public and health care providers in the early autumn. If you

only have a minute, read the National Synopsis that rolls up the findings from those consultations. You will see that we made quite a lot of progress as we sought input from providers, and their patients and clients, about the fundamental principles and framework elements that will support more interdisciplinary collaboration. You can't beat input from real people, with real experiences!

A companion to these reports is the Workbook Analysis, which is based on detailed workbooks completed by health care providers. All of these reports are posted at www.eicp-acis.ca.

We've also launched **two on-line surveys**—one designed for the public and the other for health care providers. Both will tell us more about real-life experiences, good and bad, with primary health care delivery and attitudes about moving toward more collaboration among health care professionals.

In the late autumn, we were back out in the field, extending our reach and engaging more people in the health care sector via a series of regional workshops. We wanted to see if we are still on the right track, especially vis-à-vis our foundation pieces—the principles and the framework for interdisciplinary collaboration in primary health care in Canada.

Information and perspectives are pouring in and we are busy synthesizing all we've heard and learned. We hope you will keep an eye on our progress.

EICP Principles and Framework

As the EICP Initiative proceeds with its consultations and research, the principles and the framework are coming into sharper focus.

At this early stage, the Initiative has developed a "**snapshot**" of the EICP principles and framework to convey a sense of what might be required for Canada to build a primary health care system that values and encourages interdisciplinary collaboration. This snapshot is based on input from primary health care providers and the public, literature reviews and research reports. The EICP Initiative remains open, however, to new input. Spotlight on Collaboration

Rashna Batliwalla is an Ottawa community pharmacist about to work much more closely with a very important part of the community: its family practice physicians.

"My responsibilities will be as a non-dispensing pharmacist at the Riverside Family Health Network," explains Batliwalla. "The eight family doctors there will be able to refer particular problem patients to me and I can identify drug-related problems."

While such arrangements exist only sporadically in Canada, Batliwalla is among seven Ontario pharmacists embarking part-time in the next several weeks on an initial year-long trial called IMPACT – Integrating Family Medicine and Pharmacy to Advance Primary Care Therapeutics.

Two New Surveys for Health Care Providers and the Public

These on-line surveys are key components of the EICP research and consultation program and will provide quantitative findings that complement recent EICP face-to-face consultations with health care professionals, and their patients and clients, across Canada.

Regional Workshops

The EICP Initiative has completed a series of regional workshops to validate findings from our earlier work. This time, we invited policy-makers, health administrators and people from provincial and territorial governments to join us. The results from these consultations will further refine the principles and framework for interdisciplinary collaboration.

What's Ahead?

Barrier/Enabling Factors Task Groups

In the new year, the EICP Initiative will take a more targeted approach to its consultations via Barrier/Enabling Factors task groups. This consultative exercise will focus on the specific issues that can encourage or stand in the way of collaboration in primary health care. Participants with specific expertise will be invited to contribute to task groups focused on the following topics:

- Liability/risk management
- Funding
- Electronic health records
- Regulatory factors
- Health human resources
